### **Board Updates**

Commissioner Thompson reported attending the Aging and Adult Care meeting; and, the Columbia Basin Development League (CBDL) annual conference, noting information gained at the meeting.

Commissioner Blankenship reported advertisements have been placed for Request for Proposals for the Broadband Fiber-to-the-Home Design Work; Additionally reported was his attendance at the County Leaders Conference noting he participated in Broadband funding workshops noting a new round of Broadband grant applications will open this week through

January 17, 2023. Information on county Boards of Equalization was reviewed at the conference. Adams County is eligible for two (2) additional ARPA supplemental local access payments of approximately \$95,000.00 each.

Commissioner Weise reported the Public Works Union has accepted the Collective Bargaining contract with the logistics of obtaining signatures being worked out. The Courthouse contract has not been finalized at this time. Additionally, Weise reported on his attendance at the Adams County Development Council (ACDC) meeting noting ACDC is considering a revamping of the by-laws. Commissioner Weise reported attending the County Leaders Conference noting sessions he participated in; and, his attendance at the Martin Hall meeting.

# **Board Discussion/Decision Items**

### **Human Resources**

Manager Campbell reported on the interview process for the Public Works facilities manager position. Integrated Health Care Department staffing was reviewed as there are several open positions with a discussion of attracting applicants through different avenues of advertising. Commissioner Weise reviewed the possibility of a formal workshop to meet and discuss the recruitment process with department heads and elected officials. Additionally, Campbell noted open enrollment ends November 30; and, she will be traveling to Othello to meet with staff there that may require assistance with the process.

# Executive Session – Employee Evaluation

The Board recessed into Executive Session under RCW 42.30.110(1)(g) – "To evaluate the qualifications of an applicant for public employment or to review the performance of a public employee." Employee evaluation was held from 10:36 a.m. until 11:06 a.m. Public Works Director O'Brien was present.

### **Other Business**

### **Quarterly Jail Inspection**

Jail Administrator Nick Williams reported on upgrades to the jail facility; maintenance currently being performed; current staffing; and, the number of inmates being housed in alternate facilities.

### **Public Works Personnel**

Based on the annual performance evaluation of Public Works Director O'Brien, the Board provided consensus authorization to grant a step increase from M9/S5 to M9/S6 on the Adams County Management Level Salary Schedule, effective January 1, 2023.
