REGULAR SESSION

The regular session was called to order at 6:00 p.m.

INVOCATION

Pastor Les Baugh, Anderson Community Church, gave the Invocation.

PLEDGE OF ALLEGIANCE

Councilmember Susie Baugh led the Pledge of Allegiance.

PRESENTATIONS

Shasta County Board of Supervisor Les Baugh thanked Chief Michael Johnson and the Anderson Police Department for their continued dedication to reducing crime in the City of Anderson and presented Certificates of Appreciation to the Anderson Police Department's Problem Oriented Policing (POP) Unit; Chief Johnson, Lieutenant Harpham, Sergeant Day, Officers Duncan, Hallagan and K9 Aero, and Public Service Officer Kelley.

Chief Johnson and Sergeant Day thanked Supervisor Baugh and the Board of Supervisors for the recognition and Sgt. Day gave a brief overview of what the POP program was about.

Supervisor Baugh further expressed his appreciation to the Mayor and City Council for sending a representative to the Board of Supervisor's Public Safety meeting on February 7th and encouraged the City of Anderson to get their infrastructure needs list ready to submit to the USDA Rural Development.

Don (Pappy) Walton requested the Council's support with a Veterans Parade on July 3rd to be coordinated with the Anderson Explodes Fireworks.

Mayor Connick requested Vice-Mayor Neutze to contact Mr. Walton to discuss the matter.

Melissa DeAraujo requested the City complete the neighborhood park on Humbug Drive to provide safety for neighborhood children, reduction of blight, and to fulfill the original promise to the homeowners that a park would be established at that location.

PUBLIC HEARINGS

PUBLIC HEARING: INTRODUCE AN ORDINANCE REGULATING RECREATIONAL MARIJUANA ACTIVITIES

City Attorney Jody Burgess gave a staff report, update on status of marijuana, and answered questions from the Council.

6:28 p.m.: The Public Hearing was opened.

Cameron Mooney, representing The Shasta Chemical People and Cathy Grindstaff, representing Sobering Choice Coalition spoke in support of the proposed ordinance and provided packets of information to the Council regarding recreational marijuana use.

No one spoke against the proposed ordinance.

6:38 p.m.: The Public Hearing was closed.

City Attorney Burgess reiterated the proposed ordinance is in response to the passage of Proposition 64 and not the Compassionate Use Act.

By motion made, seconded (Baugh/Neutze), and carried by a 5-0 vote, the Council introduced an Ordinance (1st Reading), amending Title 17 of the Anderson Municipal Code by adding Section 17.67 Regulating Recreational Marijuana Activities in the City of Anderson and set it for enactment (2nd Reading) for February 20, 2018.

The City Clerk read the ordinance by title only.
