ESTABLISHING ANGLE PARKING ON VARIOUS CITY STREETS

Director of Engineering and Development Russ Wenham gave a staff report and answered questions from Council.

By motion made, seconded (Neutze/Browning) and carried by a 5-0 vote, the Council voted To introduce an Ordinance (First Reading), amending the City of Anderson Municipal Code Title 10 (Vehicles and Traffic), Chapter 10.32 (Stopping, Standing, and Parking) by adding Section 10.32.290 (Angle Parking), to establish angle parking on various City streets and set for enactment on January 19, 2021 (second reading).



Councilmembers used this time to report on meetings and activities they participated in and to announce upcoming events.


