ORDINANCE NO. 2001-444

AN ORDINANCE TO INCREASE CERTAIN SPEED LIMITS ON CERTAIN CITY STREETS WITHIN THE CITY LIMITS OF BAYOU LA BATRE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAYOU LA BATRE, ALABAMA AS FOLLOWS:

SECTION ONE: <u>HEMLEY ROAD</u>: The City Council of the City of Bayou La Batre has determined that it is in the best interest of the community and the public to increase the speed limit on Hemley Road from Mary's Street to the intersection of Hemley Road and Davenport Street from twenty-five (25) miles per hour to thirty-five (35) miles per hour and;

SECTION TWO: RAILROAD STREET: The City Council of the City of Bayou La Batre has determined that it is in the best interest of the community and the public to increase the speed limit on Railroad Street from Alba Street to Niolin Street from twenty-five (25) miles per hour to thirty-five (35) miles per hour and;

SECTION THREE: <u>DAVENPORT STREET</u>: The City Council of the City of Bayou La Batre has determined that it is in the best interest of the community and the public to increase the speed limit on Davenport Street from Castelin Avenue to Hemley Road from twenty-five (25) miles per hour to thirty-five (35) miles per hour and;

SECTION FOUR: <u>PENALTY</u>: Any violation of the aforementioned speed limits shall constitute a fine of not less than Ten (\$10.00) Dollars and not more than One Hundred (\$100.00) Dollars plus cost of Court or five (5) days in the Municipal Court Jail or both which shall be at the discretion of the Municipal Court Judge.

SECTION FIVE: SEVERABILITY

The provision of this Ordinance shall supercede any conflicting provisions of any other ordinances and should any provision of this Ordinance be declared invalid or unenforceable by a Court of competent jurisdiction, the remaining provisions shall remain in full force and effect notwithstanding such invalidity.

SECTION SIX: EFFECTIVE DATE

This Ordinance shall be in full force and effect upon its adoption by the City Council of the City of Bayou La Batre and publication as required by law.
