 - a. Chairperson Karla Jones stated that Liza has already been approved by the City Council, so we can make her work tonight.
 - b. Khathlyn Micheli made a Motion to approve Liza Micheli's request to join the Carlin Planning Commission and all related matters. Anna Claudine Meierhoff seconded. Motion passed.

the one who numbers them, and whether when he wrote them in, he didn't say Carlin Avenue or Chestnut Avenue, he put Chestnut Street, or whether when it got approved by the Planning Board or when it got approved at the Council meetings that they missed that and so now it has always been that whole section off of Second Street is known as Chestnut Street.

- c. Council Liaison Cameron Kinney stated ½ Chestnut Street.
- d. Chairperson stated that there are four houses in the cul-de-sac.
- e. Vice Chairperson Jan Brizee stated that she doesn't think that there is enough room for there be an actual street because there isn't really enough distance to put in a real street there, so I don't know why it has Chestnut Avenue. It's just weird.
- f. Chairperson Karla Jones stated that it isn't properly set up for an ingress and egress, but it's been there since 1992.
- g. Vice Chairperson Jan Brizee stated that it's neither here nor there. It's not up to us to fix that. It's an anomaly to me. I just wanted to throw that out there for discussion. It has been a residence and it's going to continue to be a residence. Looks like it was a modular home and they're looking to sell it now, so I don't have a problem with it being rezoned. It should be rezoned.

So all these guys that want to sell their home, they can't get a commercial appraiser to come and do your home, so they have to get the rezone.

- j. Melinda Harris stated that she hasn't been able to talk to City Manager Madison Mahon because she has been preoccupied at the Senior Center.
