E-mailed public comments should contain the following:

- Name of person submitting comment (address can be provided, but is not required); Organization or agency person is submitting comments on behalf of, if applicable.
- Topic or agenda item number of interest or indicate if the public comment is on a matter not listed on the meeting agenda.
