#### ORDINANCE NO. 2019-02

AN ORDINANCE TO AMEND SECTION 695.03 OF CHAPTER 695, FIREWORKS, OF PART SIX, TITLE TEN OF THE CODIFIED ORDINANCES OF THE VILLAGE OF FRANKLIN, OAKLAND COUNTY, MICHIGAN, TO MODIFY AND REDUCE THE DAYS AND TIMES WHEN THE IGNITION, DISCHARGE, AND USE OF CONSUMER FIREWORKS IS LAWFUL, REPEAL CONFLICTING ORDINANCES, AND PRESCRIBE A PENALTY FOR VIOLATIONS.

### THE VILLAGE OF FRANKLIN ORDAINS:

<u>Section 1.</u> Section 695.03 of Chapter 695 of the Codified Ordinances of the Village of Franklin shall be amended, as follows:

## 695.03 USE OF CONSUMER FIREWORKS.

- (a) The ignition, discharge and use of consumer fireworks is prohibited, except on the following days after 11 a.m.
  - (1) December 31 until 1 a.m. on January 1.
  - (2) The Saturday and Sunday immediately preceding Memorial Day until 11:45 p.m. on each of those days.
  - (3) June 29 to July 4 until 11:45 p.m. on each of those days.
  - (4) July 5, if that date is a Friday or Saturday, until 11:45 p.m.
  - (5) The Saturday and Sunday immediately preceding Labor Day until 11:45 p.m. on each of those days.
- (b) A person shall not ignite, discharge or use consumer fireworks on public property, school property, or the property of another person without that organization's or person's express permission to use those fireworks on those premises.
- (c) The possession or use of consumer fireworks at any time by a minor is prohibited.
- (d) A violation of this section shall be a civil infraction for which a civil fine of \$1,000 shall be imposed.

<u>Section 2.</u> <u>Severability.</u> This ordinance and each Chapter, section, subsection, paragraph, subparagraph, part, provision, sentence, word and portion thereof are hereby declared to be severable; and if they or any of them are declared to be invalid or unenforceable for any reason by a court of competent jurisdiction, it is hereby provided that the remainder of this ordinance shall not be affected thereby.

# Section 3. Repeal, Effective Date, Adoption.

- (1) <u>Repeal.</u> All regulatory provisions contained in other Village ordinances with conflict with the provisions of this ordinance are hereby repealed.
- (2) <u>Effective Date</u>. This ordinance shall become effective upon its publication on March 17, 2019.
- (3) Adoption. This ordinance was adopted by the Village Council of the Village of Franklin at a meeting thereof held on March11, 2019.
