COMMITTEE REPORTS:

PUBLIC SAFETY AND HUMAN SERVICES – Trustee Melanie Kuban

Trustee Kuban spoke about the opportunity she and Mayor Wasowicz had on May 25th by attending the ceremony that Homeland Security hosted to present the Fifth District SWAT with valuable equipment to upgrade existing equipment and greatly improve our effectiveness.

While there, Mayor Wasowicz and Trustee Kuban had the opportunity to tour the facility and were highly impressed with the resources available at the site.

Jaws of Life, medical kits, night vision goggles and thermal imaging scopes were among the close to \$500,000.00 worth of equipment that was awarded.

Our most sincere thanks to Deputy Chief Mike Kurschner for all his work with Homeland on our behalf.

Trustee Kuban stated that she has been hearing the question from the board members regarding the next steps to implement our joining of the Fire Protection District, now that the referendum has passed.

Attorney Cainkar stated that there is a 60 day notice provision and other legal considerations that will be discussed further. Also, the District must pass a Resolution annexing the area into the Roberts Park Fire Protection District.

Public Works Work Schedule for weeks of: May 22 to June 9, 2017

US Flags were installed on major village streets.

Landscaping restoration was completed after sink holes were repaired on 83rd and Skyline Drive.

Two new storm drains were installed on Blackstone at Indian Lane.

Fresh mulch was spread around Village Hall and in areas of the parking lot.

Public Works assisted with tree planting at Village Hall and along Roberts Road.

Speed bumps were installed on 81st Ave. in the (Chief Mobile Home Park.) The driveway was widened and expanded at the Lipinski Center.

The main belts were replaced on the chipper.

New carburetors were installed on three of the weed- whackers.

A sewer was jet- rodded on 79^{th} Court and another storm sewer was located and jet rodded on the easement of 72^{nd} Street.

Sweeper screens and the water spraying system were repaired on the sweeper.

Brake cylinders were replaced on truck #22, and a new battery was installed, air-conditioner, wipers and sensors were repaired on the Ford Taurus utilized by the Administration Dept.

Tire marks were rolled out at Danhoff Park and at the Lipinski Center.

Street sweeping continues on village streets.

Spoils from Lipinski Center project's (fence & driveway) were delivered to Heartland Inc.

Two summer-help workers were hired, one directly and one from Lyons Township.

The Electric Aggregation contract is being allowed to expire since there are no favorable bids at this time. We may revisit the issue at a later date. For now, all aggregation customers will be returned to ComEd.
