**WHEREAS**, The City Official’s Election to be held on May 6, 2023 for the position of Council Member District Place 1, Council Member District Place 2 and Council Member District Place 3 and;


**WHEREAS**, as certified to the Council by the City Secretary, City of Kermit, Texas the races for Council Member District Place 1 is Rodney Hayes, Council Member District 2 is Hope Williams and Kelcey Hollingshead Short, and Council Member District 3 is Corina Chavez and with uncontested races in District Place 1 and District Place 3 and;

**WHEREAS**, Subchapter C of Chapter 2 of the Texas Election Code provides for the governing body of a political subdivision to cancel an election in a Single Member District if a candidate is unopposed and no proposition is to appear on the ballot and filing deadlines for a write-in candidate have passed




