



**MINUTES OF THE CITY COUNCIL
PERSONNEL COMMITTEE
THURSDAY JUNE 16, 2016

The Personnel Committee Meeting was held in the Mayor's Office, on the above date, with the following present: Council Members Sheryl L. Bass, Ken D. Elston, Ian T. Lovejoy, City Manager W. Patrick Pate and Human Resources Manager Darla Hicks.

The Chairman of the Committee, Council Member Lovejoy, called the meeting to order at 5:32 p.m.

Item 1 of the Agenda. Approval of the Minutes of May 19, 2016.

COUNCIL MEMBER BASS moved that the Minutes of the May 19, 2016 Personnel Committee meeting be approved. Seconded by Council Member Elston. Roll call: AYES – Bass, Elston, and Lovejoy. **MOTION CARRIED.**

Item 2 of the Agenda. Consideration of a Motion Authorizing a Closed Meeting on Subjects in Accordance with the Amended Freedom of Information Act.

COUNCIL MEMBER BASS MOVED THAT the Personnel Committee convene in closed session to discuss appointments to Boards, Committees and Commissions, as permitted by Virginia Code § 2.2-3711 Paragraph A (1), for which the Virginia Freedom of Information Act permits discussion in closed session. Seconded by Council Member Elston. Roll call: AYES –Bass, Elston and Lovejoy. **MOTION CARRIED.**

Chairman Lovejoy stated that he, Ms. Bass and Mr. Elston would be included in the closed session for the purpose of conducting interviews with applicants for the open positions on the City's Boards, Committees and Commissions.

The Personnel Committee went into closed session at 5:32 p.m.

Item 5. Consideration of a Motion Certifying That the Closed Meeting was Conducted in Conformity with Virginia Law.

COUNCIL MEMBER BASS MOVED THAT the Personnel Committee certify that in the closed session just concluded, nothing was discussed except the matter (1)



A motion was duly made, seconded and **CARRIED UNANIMOUSLY** to adjourn the meeting.


Chairman Lovejoy declared the meeting adjourned at 7:00 p.m.
