QUESTIONS AND ANSWERS:

1. *Please clarify the mowing limits along the sloped banks of the lagoons at the WWTP. A visible mow line from previous seasons was observed.*
The visible mow line is the limits of mowing. The mowing area extends from approximately 20' from the road shoulder to where the slope begins to increase. The limits of mowing at the top of the bank area are similar- mow from the road to where the slope begins to increase.
2. *What chemicals does Northglenn use to control weed growth?*
Northglenn uses the following chemicals, but does not limit a vendor the following products, Active Plus, Prodiamine, Strike 3, Vista, Cornerstone Plus, and Rodeo. Additional information for weed control is provided on page 25 (page 2 of Exhibit A) of the IFB.
