The Pipestone County Board of Commissioners met with Commissioners Luke Johnson, William (Bill) Johnson, Bruce Kooiman, Harold (Butch) Miller and Jerry L. Remund for the Annual Organizational Meeting. County Administrator Sharon Hanson also present. County Commissioner Miller called the meeting to order at 9:00 AM with the Pledge of Allegiance to the Flag.

ELECTION OF BOARD CHAIR AND VICE-CHAIR

Administrator Hanson called for nominations for Chair. Commissioners Miller and Remund nominated Commissioner William (Bill) Johnson. Administrator Hanson called for further nominations. Hearing none, motion by L. Johnson, seconded by Miller to cease nominations and cast unanimous ballot for Commissioner William (Bill) Johnson as Chair. Motion carried unanimously. Commissioner W. Johnson assumed duties as Chair and presided over the meeting.

Chairman W. Johnson called for nominations for Vice-Chair. Motion by Miller, seconded by Remund to nominate Commissioner Bruce Kooiman for Vice-Chair. Chairman W. Johnson called for further nominations. Hearing none, Chairman W. Johnson declared that nominations cease and cast a unanimous ballot for Commissioner Bruce Kooiman as Vice-Chair. Motion carried unanimously.

Motion by Remund, seconded by L. Johnson to approve the agenda. Motion carried unanimously.

RESOLUTION 59-09-14 ALTERNATIVE METHOD TO DISSEMINATE BIDS AND REQUESTS

County Engineer David Halbersma joined the meeting. Motion by Remund, seconded by L. Johnson to adopt Resolution 59-09-14 per Minn. Statute § 311A.03 Subd. 3(b), that allows a county to use its web-site or recognized industry trade journals as an alternative to disseminate solicitations of bids, requests for information and requests for proposals and that the County of Pipestone may use the Pipestone County website, www.pipestone-county.com, as an alternative means to disseminate solicitations of bids, requests for information, and requests for proposals for transportation related construction and maintenance projects and that for the first six (6) months after this designation of an alternative means of dissemination, the County shall continue to publish solicitations of bids, requests for information and request for proposals, in the same official newspaper of the county in addition to the alternative method and that the publication in the official newspaper must indicate where to find the designated alternative method. Motion carried unanimously. Engineer Halbersma informed the Board that he will likely continue to publish the solicitation of bids beyond the minimum six (6) months to ensure public notice.

RESOLUTION 59-10-14, 59-11-14 SUPPORT AND MAINTENANCE OF ADA CURB RAMPS, PROJECT UPDATES

Motion by L. Johnson, seconded by W. Johnson to adopt Resolution 59-10-14 that supports Pipestone County's correction of deficiencies in the sidewalk curb ramps along the County State Aid Highways that will help improve the mobility of the disabled community within the cities and also benefit all pedestrians throughout the County and supports the application for a grant to fund improvements through the Transportation Alternatives Program (TAP). Motion carried unanimously.

Motion by Remund, seconded by Miller to adopt Resolution 59-11-14 that states that Pipestone County is the sponsoring agency for the Transportation Alternatives project identified as Pipestone County ADA Curb Ramp Reconstruction and that the County agrees to operate and maintain facilities constructed with federal transportation funds for the useful life of the improvement and not change the use of right of way or property ownership acquired without prior approval from the Federal Highway Administration (FHWA) and that the County assume full responsibility for the operation and maintenance of property and facilities related to this project. Motion carried unanimously.

County Engineer Halbersma updated the Board on the following Projects: County State Aid Highway (CSAH) 10, Cemetery Road (Highway 267), seal coat projects and motor grader replacement.

Motion carried unanimously.
