v. APPLICANT SIGNATURE

VII. FEE CLARIFICATIONS

ITEM # 17, MOBILE HOME UNIT SITE: When installing a site service in a park, the permit application must include the application fee, service, plus that number of park sites. When setting a HUD mobile home in a park, a permit must include the application fee and a feeder. This shall be done by a licensed electrical contractor. When setting a HUD mobile home or a pre-manufactured home on private property, a permit must include the application fee, service and feeder.
