The doors of the stately 200-year-old mansion open. George Calvert and his wife, Rosalie Stier Calvert, welcome you into their home as the smells of gingerbread, spices and pine and the sounds of festive music waft through the air.

Riversdale House Museum invites you to relax during this busy season in the warm glow of our candlelit **1812 Winter Evening on Friday, December 28, from 6-9pm**. The house will be festooned with seasonal greens and period music will play as costumed interpreters representing family, friends, and servants of the house interact with visitors on their self-guided tours of the illuminated mansion. "My house is full of people every day and night," wrote Mrs. Calvert in 1814. Some of those visiting War of 1812 military troops add to the cheery atmosphere of the evening. Cooking over an open hearth fire in the kitchen, children's activities, and warming refreshments are all part of the spirit of the evening.

Admission for the event is \$5.00 for adults and free for accompanying children 12 and under. No reservations are necessary. The house is open 6:00-9:00 p.m. and refreshments are provided with admission.

### TOWN OF RIVERDALE PARK FAIR SUMMARY OF ORDINANCE 2012-OR-12

This is to give notice that the Riverdale Park Town Council has introduced and intends to take action on Ordinance 2012-OR-12.

Ordinance 2012-OR-12 would amend the Capital Improvement Program (CIP) Budget for the Town of Riverdale Park for the fiscal year beginning July 1, 2012, and ending June 30, 2013. This amendment would add to the FY 2013 CIP a new appropriation in the amount of \$525,000 for the purchase of real estate, to be funded from the sale of bonds.

Ordinance 2012-OR-12 is available for inspection by the public at Town Hall during normal business hours, 8:30 a.m. to 4:30 p.m., Monday through Friday.

### **Finance Committee Report**

Happy Holidays!

The Finance Committee met in late October. We discussed the status of our annual accounting audit by the State of Maryland, how the budget was moving along (in particular some items, like spending on Cafritz consulting, that have been issues in the past), what financing process we would need to go through to purchase the property on the southeast corner of Baltimore Avenue (US Route 1) and Madison Street (the property known as "Jey's Auto"), and whether the budget amendment for legal expenses was the right amount or needed to be changed (we left it alone). Town Administrator Imhulse also updated us on the status of various projects that have been in the works for a while. including a major revision of the personnel manual, and a system for electronic voucher processing, which should improve the town's efficiency in paying bills.

I was honored to speak at Riverdale Park's observance of Veterans Day on November 11 at the Veterans Monument; I thank our veterans, as well as everyone who turned out for the event. I also want to thank all departments of Riverdale Park's

town government for helping the event to go smoothly.

The Preliminary Plan of Subdivision for the Cafritz project has been significantly revised and submitted to Parks and Planning for review and approval (or denial) by the Planning Board in January. This plan lays down the location and size of streets and building lots, and part of the approval process is verifying that there are sufficient public facilities (police, fire department, public schools, parks, storm water capacity, etc.) to meet the needs of the new development. The most important part of the plan is that it now has a definite location for the bridge across the CSX railroad tracks. The bridge location, which is still subject to approval by the American Center for Physics (ACP), puts the bridge at the southern boundary of the ACP property, with the road coming out on Rivertech Court roughly where the ACP driveway nearest Raytheon comes out now (a slightly different version, which may be implemented, has the road making a right turn and coming out at the current circle on Rivertech Court). This plan for the bridge is much better than other proposals that have been discussed, and will allow easy access to the bridge (both by car and on foot) to most of Ward 2 while discouraging traffic from cutting through our neighborhood. This is the last Town Crier before the Preliminary Plan is either approved or rejected, so if you have concerns or want to know more please contact me or Mayor Archer to learn more and let us know what you think.

As we head full-speed into the holiday season, I'd like to remind everyone that the Town's Holiday Market and Festival of Lights will be held this year on Saturday, December 15<sup>th</sup> from 12:00 noon to 8:00 pm. Pick up presents and a bite to eat during the day, and at night trolleys will go through town so riders can see our town's holiday decorations. I hope to see you all there!

# **Public Works Report**

Saturday Drop Off – The next scheduled date for drop off of bulk trash on the third Saturday of each month, from 9:00 AM – 2:00 PM, is on December 15. The January – June 2013 schedule is as follows: January 19, February 16, March 16, April 20, May 18 and June 15.

# <u>Holiday Collection</u> – Happy Holidays to Riverdale Park residents!

- Regular trash <u>WILL BE</u> collected on Christmas Eve, Monday, December 24, 2012, and on New Year's Eve, Monday, December 31, and on Monday, January 21, 2013, Martin Luther King's birthday.
- Holiday Closing The Department of Public Works will be closed on Christmas Day, Tuesday, December 25, 2012, New Year's Day, Tuesday, January 1, 2013, and Monday, January 21, 2013, in recognition of Martin Luther King's birthday.

<u>Leaf Collection</u> - As part of our fall leaf collection services, leaves will be collected from **November 15<sup>th</sup>** through **January 15<sup>th</sup>**. DPW will vacuum leaves from Town streets following our previous trash collection schedule. Please see map below.

In order to make this process work as efficiently as possible, residents are encouraged to:

- Rake leaves to the curb. Pile leaves away from cars and storm drains. The leaf vacuum cannot reach around cars.
- Remove tree limbs, rocks and other debris from leaves to be collected. They

- can damage the equipment and cause delays.
- Please put bagged leaves out on Wednesdays with the yard waste. Do not put them out with regular trash.

Noise and dust may be noticeable during the leaf vacuuming process. Dry conditions generate more dust. We apologize for any inconvenience.



### What is a State or County Road?

The State Highway Administration (SHA) is responsible for all State roads. Most State roads are identified by route number and are posted with signs indicting those route numbers. For example, Route 410- East-West Highway, Route 201- Kenilworth Avenue, Route 1-Baltimore Avenue, and the Capital Beltway is Interstate Route 495-95,

are State roads. Please call 301-513-7300 for maintenance problems on State roads.

The Prince George's County Department of Public Works and Transportation (DPW&T) is responsible for all County roads. County roads are identified by road names only. For example, Good Luck Road is a county road. For highway and traffic problems in the County, please call 301-499-8600.

Municipal Streets are the responsibility of the individual city or town governments within their respective city limits. Exceptions may be major thoroughfares through a city which may be maintained by either the State or the County, i.e., Riverdale Road. For problems with Town streets, please call the Department of Public Works in Riverdale Park at 301-864-1803.

If you are unsure if the route, road or street is a State, County or Municipality, respectively, please contact the Right-of-Way Division of the DPW&T at 301-883-5642.

Some roadways are private or designated "other public" roads and must be maintained by the property owner.

Bulk Trash Pickups & Special Trash Pickups
Bulk Trash pickups are scheduled by
APPOINTMENT ONLY. In order to have bulk
items picked up on Wednesdays, you must call
Bates Trash and Trucking Company at 301-7732069, before 2:00 PM on Tuesdays.

Items must be at curbside by 7:00 AM on Wednesdays. Bates is not required to pick up more than **THREE** (3) bulk items from any one-family dwelling per week. If you have more than three (3) items, you can make another pick up appointment on the following Wednesday.

The following items will **not** be picked up: building materials, concrete, bricks, roof shingles, stumps, bamboo, pressurized containers, explosives, paint (unless paint is dry in cans), poisons, caustics, construction and demolition debris, asbestos, toilets, free liquids, sewage, sludge. These items can be taken to **Brandywine Sand & Gravel**, **5800** Sheriff Road, Capitol Heights, MD. 301-925-8100, or to the Prince George's County Landfill, **16111** White House Road, Upper Marlboro, Maryland, 301-952-7630.

The Park Ranger made sure our fire was out.

On 1 November some of us went to the Department of Mental Health Auditorium in Baltimore, and attended Maryland's Kick-Off celebration of Native American Month. Keith Colston, Assistant Director of the Maryland Commission on Indian Affairs was the MC; there was Native food, Native dancing, Lt. Governor Anthony G. Brown read the Governor's proclamation announcing the beginning of Native American month, and exhibits for all to enjoy.

We donated 106 cans of food for Scouting for Food, too, and there's more to come!

On 16 November, we all put on our new Troop 252 Tee Shirts, fashioned by Lucian's Trophies & Awards in Bladensburg! Thank you, Rob and Bob!

On 17 November, we bicycled around Jug Bay, riding to the observation tower at the Merkle

Wildlife Sanctuary, so we can easily see why they call it "Jug Bay." AND we'll tell the "War of 1812"story to the new Scouts - the "old" Scouts know it by heart, but they appear to enjoy it again and again.

We'll go tubing the first snowfall, because we have the tubes and hill! If the weather is cold enough, we'll ice up the hill for REALLY fast rides! # **Doll Club Annual Tea Party**

The Doll Club held its Second Annual Doll Tea Party at the Montpelier Mansion in Laurel, Maryland, Oct. 21, 2012. The Doll Club is a youth study group where students learn how to make dolls by hand from the 1810 era & how to dress them including making miniature accessories. To get into the ambiance of the Regency era, the students dressed up in their 1812 fashions which consists of an 1810 dress made according to the 1810 authentic pattern, a gauze shawl dyed from roots, vegetables & fruits, a bonnet, mob cap, coral bead necklace, fancy white gloves, white knee sox and ballet type shoes. Upon entering the mansion, the students stepped back in time to be greeted by Miss Edna who smiled warmly. She then began to teach the girls how to curtsey and the gentleman to bow properly. Miss Edna took the students on a tour of the house including the hidden staircase. The students learned all about life back then and how the children were cared for plus

all the things that were different in everyday life compared to today.

The room with the early 1800 toys was challenging. The early toys were designed to keep children busy for long periods of time because there were no video games back then. The students tried their hand at the skill of early 1800's toys. After the tour, we went to the Tea Room for a party and to learn more table etiquette. All the food was in miniature size – little tea sandwiches, scones with whipped cream topping, tiny tarts, cookies, and other mini treats. Each student received a handmade dress by Miss Emily for their 10" doll which they hand made, a cherry table to fit their doll with a tiny tea set, real beeswax candles, napkin ring & cloth napkin, tiny silverware.

They also received their first 8" old collector doll. When asking the students what their favorite part of the afternoon was – some said learning how living was so different back then compared to now, some said the presents but all in all we had a great time stepping back in time. Miss Edna and her staff did a wonderful job.

The Doll Tea was sponsored in part by ATHA. The costume collection belongs to the Doll Club and was made by Emily Fanning, Michelle Burns and Mia Enns and was also sponsored in part by ATHA. The students wear their costumes to the Riverdale Park Arts Festival, Bostwick Day, the Jr. Docent program at Riversdale House Museum & other historical functions. Would also like to thank Mr. Rivas for taking us and our 2 chaperons Trudy & Tyronne Thornton. This was the grownups' first Doll Tea Party. Mr. Thornton graciously put on George Washington's white wig for all to see.

El Club de muñeca celebró su segunda fiesta anual de té el 21 de octubre del 2012, en la mansión de Montpelier en Laurel, Maryland. El Club de la muñeca es un grupo de estudio de la juventud donde los estudiantes aprenden cómo hacer muñecas a mano desde la época de 1810 y cómo ellos incluyendo hacen accesorios de vestir. Para entrar en el ambiente de la época de la regencia, los estudiantes vestidos con sus modas de 1812 que consiste en un vestido de 1810 hecho según el patrón auténtico 1810, un chal de gasa teñido de

raíces, verduras y frutas, un bonete, casquillo, coral del grano, guantes blancos de lujo, calcetas blancas a la rodilla y zapatos de ballet.

Al entrar en la mansión, los estudiantes dieron un paso atrás en el tiempo a ser saludados por Miss Edna que sonrió con gusto. Luego empezó a enseñar a las niñas cómo el caballero se inclina correctamente. Miss Edna llevó a los estudiantes en un recorrido por la casa incluyendo la escalera oculta. Los estudiantes aprendieron todo sobre la vida en aquel entonces y cómo los niños fueron atendidos más de todas las cosas que eran diferentes en la vida cotidiana que hoy.

La sala con los primeros juguetes de 1800 fue un desafío. Los primeros juguetes fueron diseñados para mantener a los niños ocupados durante largos períodos de tiempo porque en aquel entonces no había video juegos. Los estudiantes trataron con sus manos la habilidad de los primeros juguetes de 1800. Después de la gira, fuimos a la sala de té para un partido y a aprender más etiqueta en la mesa. La comida fue en tamaño miniatura poco tea sándwiches, crema batida, pequeñas tartas, galletas y otras delicias. Cada estudiante recibió un vestido hecho a mano por Miss Emily para su muñeca, una cereza tabla para el ajuste de sus muñecas con un pequeño juego de té, velas de cera de abeja real, servilletas, anillo y paño de servilleta, cubiertos diminutos.

También recibieron su primera muñeca antigua de 8 pulgadas de la coleccionista. Al pedir a los estudiantes lo que fue su parte favorita de la tarde – algunos dijeron cómo la vida era tan diferente a continuación, en comparación con ahora, algunos decían que los regalos pero todo tuvimos un gran tiempo atrás en el tiempo de aprendizaje. Miss Edna y su equipo hicieron un trabajo maravilloso.

El té de la muñeca fue patrocinado en parte por ATHA.

La colección de traje pertenece al Club de muñecas y fueron hechas por Emily Fanning,

Michelle Burns y Mia Enns, también fueron patrocinadas por ATHA. Los estudiantes usan sus disfraces para el Festival de Artes de Riverdale Park, el dia de Bostwick, el programa docentes Jr. en la Casa Museo de Riversdale y otras funciones históricas. También quisiera dar las gracias al Sr. Rivas, Trudy & Tyronne Thornton. Esta fue la primera fiesta del Te de los adultos. Sr. Thornton amablemente se puso la peluca blanca de George Washington para todos.
