**Special 3 Day Filing Period:  
May 31<sup>st</sup> – June 2<sup>nd</sup>, 2023**

Our office will hold a special 3-day filing period. The offices open are those which no candidate filed for during the regular candidate filing period, May 15<sup>th</sup> – May 19<sup>th</sup>.

This special 3-day filing period begins on Wednesday May 31<sup>st</sup>, 2023 at 9:00 a.m. and closes Friday June 2<sup>nd</sup>, 2023, at 4:00 p.m.

Candidates may electronically submit declarations of candidacy through our website at: <https://voter.votewa.gov/candidatefiling/candidatelogin.aspx>, or candidates may file in-person at the Elections Office, 315 W. Main St., Room 203, Walla Walla.

The submitted information must be legible, timely and satisfy all legal requirements (RCW 29A.04.255 and WAC 434-208-060). Candidates are responsible for ensuring they meet all qualifications for that office.

If a fee is required, the electronic filing is not complete until the fee is received. The fee must be received by 4:00 p.m. on Friday, June 2<sup>nd</sup>, 2023 (WAC 434-208-060). Credit Card payments will be accepted through the online filing process.

Filing Fees are **NOT** refundable.

There is no withdrawal period for declarations of candidacy filed during a special filing period. (RCW 29A.24.131)
