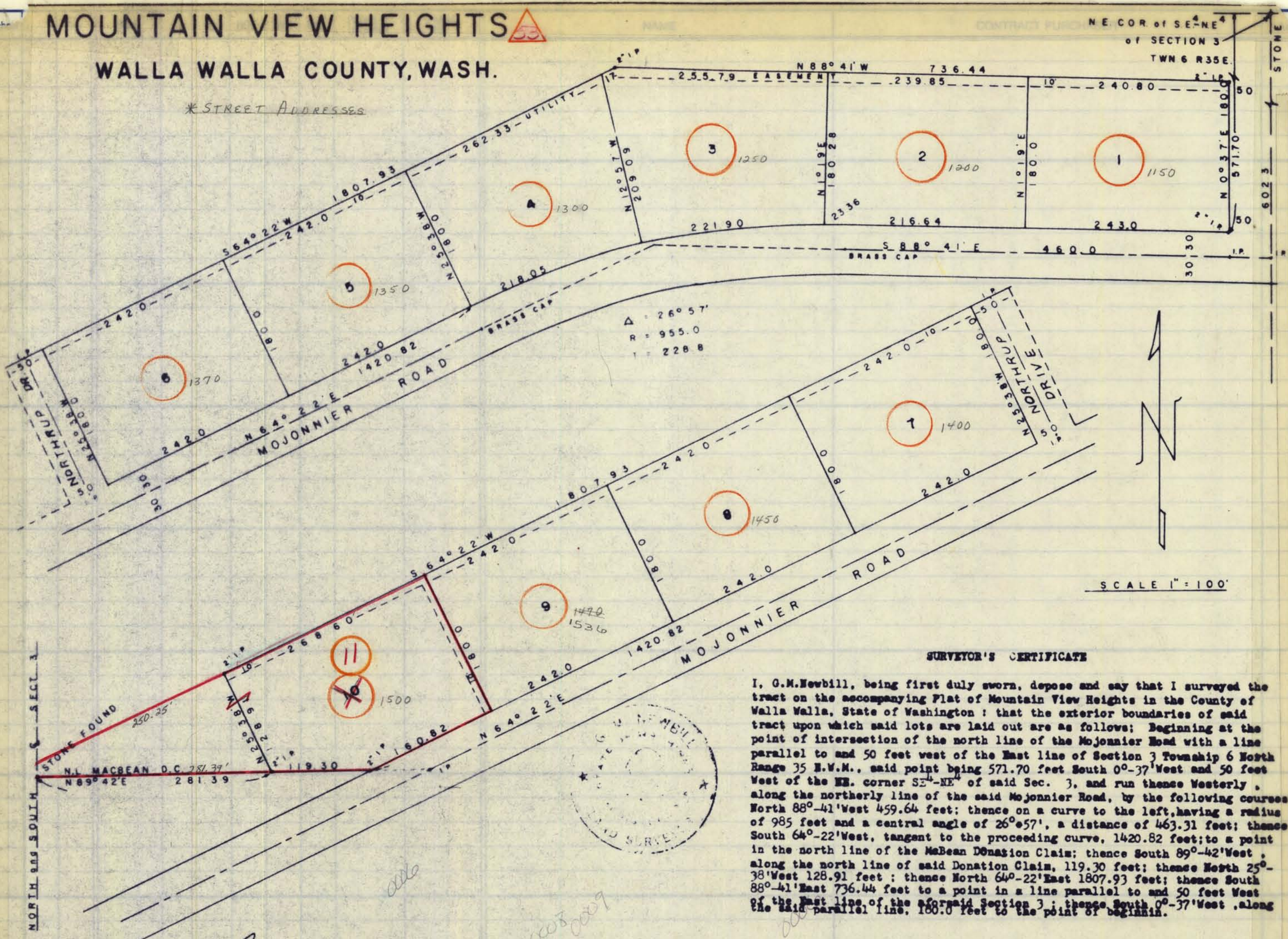

SURVEYOR'S CERTIFICATE

I, G.M. Newbill, being first duly sworn, depose and say that I surveyed the tract on the accompanying Plat of Mountain View Heights in the County of Walla Walla, State of Washington; that the exterior boundaries of said tract upon which said lots are laid out are as follows: Beginning at the point of intersection of the north line of the Mojonnier Road with a line parallel to and 50 feet west of the East line of Section 3 Township 6 North Range 35 N.W.M., said point being 571.70 feet South 0°-37' West and 50 feet West of the NE. corner SE⁴-NE⁴ of said Sec. 3, and run thence Westerly, along the northerly line of the said Mojonnier Road, by the following courses: North 88°-41' West 459.64 feet; thence on a curve to the left, having a radius of 985 feet and a central angle of 26°-57', a distance of 463.31 feet; thence South 64°-22' West, tangent to the preceding curve, 1420.82 feet; to a point in the north line of the McBean Donation Claim; thence South 89°-42' West, along the north line of said Donation Claim, 119.30 feet; thence North 25°-38' West 128.91 feet; thence North 64°-22' East 1807.93 feet; thence South 88°-41' East 736.44 feet to a point in a line parallel to and 50 feet West of the East line of the aforesaid Section 3; thence South 10°-37' West, along the said parallel line, 180.0 feet to the point of beginning.
