ORDINANCE NO. 488, as follows: AMENDING CHAPTER 12 OF THE WALLA WALLA COUNTY COMPREHENSIVE PLAN, THE BURBANK SUB-AREA PLAN, AND THE WALLA WALLA COUNTY ZONING CODE, TITLE 12, TO ADOPT A NEW RESIDENTIAL DEVELOPMENT STANDARDS FOR URBAN RESIDENTIAL USES IN THE BURBANK URBAN GROWTH AREA (DOCKET ZCA18-003).
