Citrix Access Gateway server is End of Life and we now find that to solve some of the remote access issues we have to reboot that server. Our goal was to move to a different technology to allow remote access into our network. During the 2014 budget process we were asked to make budget cuts. Moving to the new technology was one of the items postponed.

The result of the 2014 budget process was that all the departments were to get a 2% increase in the budget. However, not all departments got a 2% increase as is the case for Technology Services, though we had to make cuts like every other department.

The cost to replace the server is between \$4000 and \$5000 then pay annual maintenance.. However the cost to purchase a license key for our firewall, to allow secure access is less than \$3000.00 and since we already pay for maintenance for that device, we would not need to pay additional annual fees.

It appears that the Sheriff's department has returned \$13,000 to current expense. Would the BoCC be willing to allow a budget amendment to increase the Technology Services budget by \$3000 to cover this cost? If so, I could follow up with a proposal in the next week or two.
