

**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD
AUTHORIZING AN ON-LINE AUCTION OF
CERTAIN VEHICLES AND EQUIPMENT**

WHEREAS, the Township of West Deptford is the owner of certain vehicles and other personal property equipment not needed for public use; and

WHEREAS, the Township desires to sell the vehicles and personal property to provide revenue for the Township for the benefit of its residents; and

WHEREAS, Mayor and Township Committee have determined that it is in the best interest of the Township to auction said vehicles and other personal property equipment to the highest bidder in accordance with the provisions of N.J.S.A. 40A:11-36; and

WHEREAS, the Mayor and Township Committee wish to auction said vehicles and other personal property equipment via an on-line website authorized by the New Jersey Division of Local Government Services, GovDeals.com; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of West Deptford, County of Gloucester and State of New Jersey on this 20th day of September 2012 as follows:
