

**RESOLUTION OF THE TOWNSHIP OF WEST DEPTFORD
AUTHORIZING THE EXECUTION OF A TEMPORARY AGREEMENT
FOR PROFESSIONAL SERVICES BY A FINANCIAL ADVISOR
FOR A 90 DAY PERIOD AND AUTHORIZING THE TOWNSHIP TO
PUBLISH A REQUEST FOR PROPOSALS FOR FINANCIAL
ADVISORS FOR 2013**

WHEREAS, there exists a need to retain a Financial Advisor for the Township of West Deptford; and

WHEREAS, funds are available for this purpose; and

WHEREAS, the Township of West Deptford, prior to the award of this contract for "Professional Services," has complied with the dictates of *N.J.S.A.* 19:44A-20.5, and its Ordinance establishing a Fair and Open Process for the Award of Professional Service Agreements and Other Agreements with Business Entities adopted pursuant thereto, requiring that all contracts for "Professional Services" be awarded pursuant to a fair and open process; and

WHEREAS, the Township of West Deptford has awarded this temporary contract for "Professional Services" after undertaking to consider all proposals submitted pursuant to the Fair and Open Process required by *N.J.S.A.* 19:44A-20.5, and the Township's Ordinance establishing a Fair and Open Process for the Award of Professional Service Agreements and other Agreements with Business Entities.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of West Deptford, Gloucester County, New Jersey, as follows:

1. That **Phoenix Advisors, LLC**, be and is hereby appointed **Financial Advisor** for the Township of West Deptford for a 90 day appointment commencing January 1, 2013 and ending March 31, 2013 as per the terms of the Agreement attached hereto and the Mayor and Township Clerk are hereby authorized and directed to execute said Agreement on behalf of the Township pursuant to *N.J.S.A.* 19:44A-20.5, and the Township's Ordinance establishing a Fair and Open Process.
2. A Notice stating the nature, duration, service and the amount of the contract and that this Resolution and contract are on file and available for public inspection in the office of the Township Clerk shall be published in *The South Jersey Times*.
3. That the Township Committee authorizes the Administrator/Purchasing Agent to publish a request for proposals for Financial Advisor and accept proposals from qualified applicants.
