**RESOLUTION AUTHORIZING THE TOWNSHIP OF WEST DEPTFORD TAX COLLECTOR TO PREPARE AND MAIL ESTIMATED TAX BILLS IN ACCORDANCE WITH P.L. 1994, c.72**

**WHEREAS**, the Township of West Deptford has scheduled tentative budget adoption on August, 1<sup>st</sup>, 2013 and the Gloucester County Board of Taxation is unable to certify West Deptford Township's tax rate at this time and the West Deptford Township Tax Collector will be unable to mail the Township's 2013 tax bills on a timely basis;

**WHEREAS**, the West Deptford Township Tax Collector in consultation with the West Deptford Township Acting Chief Financial Officer has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and they have both signed a certification showing the tax levies for the previous year, the tax rates and the range of permitted estimated tax levies;

**WHEREAS**, in accordance with Chapter 72, P.L. 1994, the Township Committee requests the Director of the Division of Local Government Services to approve the estimated tax levy not to exceed 105% listed below. Approval will enable the Township to meet its financial obligations, maintain the tax collection rate, provide uniformity for tax payments and save the unnecessary cost of interest expenses on borrowing.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WEST DEPTFORD, IN THE COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY** on this 20<sup>th</sup> day of June, 2013 as follows:


1. The West Deptford Township Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the Township for the third installment of 2013 taxes. The Tax Collector shall proceed upon approval from the Director and take such actions as are permitted and required by P.L. 1994, c.72 (N.J.S.A. 54:4-66.2 and 54:4-33.3).
2. The entire estimated tax levy for 2013 is hereby set at **\$65,273,436.40**.
3. In accordance with law the third installment of 2013 taxes shall not be subject to interest until the later of **August 11<sup>th</sup>** or the twenty-fifth calendar day after the date the estimated tax bills were mailed. The estimated tax bills shall contain a notice specifying the date on which interest may begin to accrue.


