

**RESOLUTION AUTHORIZING A PERMIT FOR A FIREWORKS DISPLAY AND  
AUTHORIZING THE PURCHASING AGENT TO EXECUTE A CONTRACT FOR  
WEST DEPTFORD FUN DAY PUBLIC FIREWORKS DISPLAY**

*WHEREAS*, the Township of West Deptford will again sponsor this year's public display of fireworks to be held at the RiverWinds Community Center on the evening of September 7, 2013, with the rain date to be Sunday, September 8, 2013; and

*WHEREAS*, the Township of West Deptford is desirous of continuing the tradition of a Fun Day public fireworks display by sponsoring said event, and has solicited proposals which were opened on July 18, 2013 where two (2) proposals were received; and

*WHEREAS*, the Township of West Deptford wishes to engage Schaefer Pyrotechnics for the Fun Day fireworks display in the amount of \$3,750.00, with a deposit of \$1,250.00 paid one (1) week prior to event; and

*WHEREAS*, such display will be supervised by competent and experienced person in compliance with N.J.S.A. 21:3-4 of the State of New Jersey, and will not be a detriment to the community, but to the contrary will offer substitute for the heretofore indiscriminate and unlawful use of fireworks on the part of the individuals.

***NOW THEREFORE, BE IT RESOLVED*** by the West Deptford Township Committee as follows:

1. Pursuant to the authority granted under N.J.S.A. 21:3-1, N.J.S.A. 21:3-3 and N.J.S.A. 21:3-4 of the State of New Jersey, the Fire Official of West Deptford Township be and is hereby authorized to make, execute and deliver a good and sufficient license of permit to Schaefer Pyrotechnics, authorizing the public display of fireworks during the evening of Saturday September 7, 2013 at approximately 9:00 p.m., eastern daylight time, under the supervision of Schaefer Pyrotechnics, a fully qualified pyrotechnical firm, the company named in the application heretofore submitted to the Purchasing Agent. Said license shall be without force and effect until such time as the fireworks display company, Schaefer Pyrotechnics shall file with the Purchasing Agent insurance coverage naming the Township of West Deptford as an additional insured, including a statutory bond, which are satisfactory to the Solicitor, which would indemnify any person who may receive or sustain injury to his or her person or property by reason of any discharge of the fireworks in question and a Hold Harmless Agreement to the benefit of the Township of West Deptford, in a form satisfactory to the Solicitor. All operations incidental to such display shall be subject to the approval of the Chief of Police, Craig Mangano and John Austin, Fire Official of the Township of West Deptford as required by law; and
2. If the rain date that is established is beyond the ninety-six (96) hour limit, the fireworks will be removed from the storage area in the Township and returned to the site twenty-four (24) hours prior to a new date of fireworks display.
3. The Purchasing Agent, is hereby authorized to execute the attached contract for the fireworks display between the Township of West Deptford and the fireworks provider,
